The meeting was called to order at 10:45 a.m. with a welcome by Ms. Schlageter. Roundtable introductions ensued. Ms. Schlageter expressed appreciation to the City of Deltona for continued support and use of space for the monthly Deltona Prevention Project meetings.

### Project Business

Ms. Schlageter reviewed the status of the action plan and shared that the second round of mini-grants were now closed and that she would be getting in touch with the applicants regarding status/approval. There were 8 submissions, collectively requesting \$13,000. An announcement regarding the One Voice for Volusia coalition meeting (to be held on September 9<sup>th</sup>) was made, inviting all to attend because of the topic: Substance Use: trends and update regarding prevention and recovery efforts. An update was provided regarding the 2009 Health and Human Services Summit as well as the Florida EYI Training (handouts).

Elizabeth McQueen presented "Motivational Enhancement" (powerpoint). This program discussed methods of using research based techniques to improve the motivation in individuals in an effort to promote positive change. Questions and answers ensued.
